

Jamestown Sanitary District Board of Directors

Special Public Meeting Agenda – January 5, 2023

In order to protect public health and the safety of members of the public against the COVID-19 pandemic, the Jamestown Sanitary District office and Board Meetings are physically closed to the public. This meeting will be held in accordance with the Governor's State of Emergency, declared on March 4, 2020; Cal/OSHA's recommendations for social distancing; the Ralph M. The Board makes findings required by AB 361 to continue to conduct meetings of the Jamestown Sanitary District Board of Directors using Teleconferencing Pursuant to Government Code 54953 as Amended by AB 361.
