

Jamestown Sanitary District Board of Directors

Public Meeting Agenda – August 11, 2022

In order to protect public health and the safety of members of the public against the COVID-19 pandemic, the Jamestown Sanitary District office and Board Meetings are physically closed to the public. This meeting will be held in accordance with the Governor's State of Emergency, declared on March 4, 2020; Cal/OSHA's recommendations for social distancing; the Ralph M. Brown Act (California Government Code section 54950, et seq.) as amended by Assembly Bill 361; and the Federal Americans with Disabilities Act. No physical public meeting location will be provided for this meeting. The Board makes findings required by AB 361 to continue to conduct meetings of the Jamestown Sanitary District Board of Directors using Teleconferencing Pursuant to Government Code 54953 as Amended by AB 361.
